This Cell is functional with the principal as the head and faculty members as coordinators. Anti-Ragging Cell should be one of the important parts of Educational Institution's mechanism. As per the guidelines of UGC under the Act of 1956, which is modified as UGC regulations on curbing the menace of Ragging in higher Educational Institutions, 2009, establishment of Anti-Ragging Cell is very compulsory.

As per the order of Supreme Court of India and subsequent Notification from University Grants Commission (UGC), ragging constitutes one or more of any intention by any student or group of students on:

1. Any act of Indiscipline, Teasing or Handling with Rudeness.
2. Any act that Prevents, Disrupts the Regular Academic Activity.
3. Any activity which is likely to cause Annoyance, hardship, Psychological Harm or creates Fear or Apprehension.
4. Any Act of Financial Extortion or Forceful Expenditure.
5. Any Act of Physical Abuse causing Assault, Harm or danger to Health.
6. Any Act of abuse by spoken words, emails, SMS or public insult etc.
7. Any Act of injury or infringement of the fundamental right to the human dignity.
8. Any Act of Wrongful Confinement, Kidnapping, molesting or committing unnatural offences, use of criminal forces, trespass or intimidation.
9. Any unlawful assembly or conspiracy to ragging.

Punishment to those found guilty

Any student or group of students found guilty of ragging in the campus or even outside the campus shall be liable to one or more of the following punishments.

1. Debarring from appearing in any sessional test / University Examination
2. Suspension from attending classes and academic privileges
3. Withdrawing scholarships and other benefits
4. Suspension from the college
5. Cancellation of the admission
6. Withholding the results.

Objectives of Anti Ragging Cell

Anti-Ragging Committee will be the supervisory and advisory committee in preserving a Culture of Ragging Free Environment in the college Campus. The main objectives of this cell are as follows:

1. To aware the students of dehumanizing effect of ragging inherent in its perversity.
2. To keep a continuous watch and vigil over ragging so as to prevent its occurrence and recurrence.
3. Promptly and stringently deal with the incidents of ragging brought to our notice.
4. To generate an atmosphere of discipline by sending a clear message that no act of ragging shall be tolerated and any act of ragging shall not go unnoticed and unpunished

Depending on the nature and severity of the guilt established by the Anti-Ragging cell, A student indulging in ragging can be,

1. Expelled from attending classes and academic privileges.
2. Withholding/withdrawing scholarship/fellowship and other benefits.
3. Denied from appearing in any test/examination or other evaluation process.
4. Withholding results.
5. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
6. Banned from the hostel.

An orientation programme for the students of the First-year degree was conducted on 30/9/21. Dr Milon Franz ,professor ,Department of English, St Xavier's College for women, Aluva, gave an enlighten talk on awareness about ragging and introduce the activates of anti-ragging cell of the college to the newly admitted students. Professor gave ensure the students that they have nothing to fear as the institution cares for them.

Anti ragging cell presented posters which give awareness about ragging and activates of anti ragging cell in different corners of the college. Anti ragging committee members and students representatives of anti ragging cell gave awareness to senior students about need of anti-ragging, and loving relation with the juniors. The students of St Xavier's College for Women, Aluva are here by warned that they shall not indulge in "RAGGING". If they are found guilty of ragging they are liable for the above mentioned punishment.

Anti ragging cell coordinator and joint coordinator meet every students in their classroom and gave guide line to fill anti-ragging affidavit form in UGC website. There was a periodic meeting with the committee members regarding to monitoring the activates of anti-ragging cell.

St Xavier's college campus is ragging free, still all these measures have been taken to ensure that the freshers are able to pursue their studies without getting troubled by the seniors. As the earlier academic year ,in 2021-2022 academic year also, St Xavier's college for women, Aluva, did not face any ragging situation inside and outside the college. All of this was possible only because of the whole-hearted support from students and teachers.
